BIOJET may be mixed with most liquid fertilizer and crop protection products. BIOJET may also be applied with dips, watering and transplant solutions. Conduct a jar test for compatibility prior to mixing into large formulations. BIOJET can be applied to all soil types and pH ranges.

DIRECTIONS FOR USE:

DILUTE TO 100 TIMES MINIMUM, DO NOT USE CONCENTRATED PRODUCT DIRECTLY.

STORAGE & HANDLING:

SUGGESTED APPLICATION RATES:

CROPS	RATE AND APPLICATION TIMING
VEGETABLE CROPS	Apply 2-12 pints/acre as part of soil applied fertigation or irrigation. Product may be applied through drip irrigation, pivot, side dress, pre-plant or at planting. Product can be used every 1 to 3 weeks.
FRUIT/NUT CROPS/ VINES/ANNUALS	Apply 2-12 pints/acre as part of soil applied fertigation or irrigation and post-harvest.
FIELD CROPS/FORAGE/ANNUALS/AND PERENNIAL CROPS <small>Including corn, cotton, soybeans, wheat, sugarcane, peanuts, alfalfa, hemp, etc.</small>	Apply 2-8 pints/acre from planting to mid-vegetative stage. Can be applied in furrow, at planting with starter fertilizers, side or top dress.
PROFESSIONAL LAWN AND TURF CARE	Apply 2.0-5.0 fl.oz/1000 sq.ft. with multiple application throughout the growing season. (Irrigate after each application).
HOME AND GARDEN	Apply 2-5 ml/gallon of water, throughout growing season.
